IMPORTANT NOTICE REGARDING ACCEPTANCE OF NOTICES FOR PUBLICATION IN THE WEEKLY "GAZETTES" FROM JULY 06, 1979

ATTENTION is drawn to each of the "Important Notices" appearing in the 1st week of every month, regarding the latest dates and times of acceptance of notices for publication in the weekly Gazettes at the end of each Part of the Gazette of the Democratic Socialist Republic of Sri Lanka. Under the present arrangements, the last date and time for acceptance of notices is fixed for 12 noon of each Wednesday preceding the Wednesday of the week of publication in respect of Part I: Sections (IIA) & (IIB) and Part IV (A). The date and time of closure of notices in regard to Part IV (B) and all other Parts is 12 noon of every Friday, one week prior to the date of issue of the Gazette.

With effect from July 06, 1979, all notices to be published in every Part of the Gazette shall close at 12 noon of each Friday, fortnight before the date of publication. All Departments, Corporations, Boards etc., are advised that any notification fixing specific dates for closing times of applications in regard to vacancies, tender notices, and the dates and times of auction sales, etc., should be prepared with due regard to this change, i.e., giving adequate time both from the time of despatch of notices to the Government Press and from the date of publication thus enabling those interested in the contents of the notices to actively and positively participate.

Commencing from July 06, 1979, the Schedule for each month will be amended accordingly and all notices should reach this Department positively by 12 noon of the Friday two weeks prior to the date of publication, e.g., Notices for publication in the weekly Gazette of February 08, 1980, should reach the Government Press at or before 12 noon on January 25, 1980.

REGULATION made by the Minister of Cultural Affairs under section 16 (d) of the National Archives Law, No. 48 of 1973, pertaining to Public access to Public Archives and approved by Parliament.

REGULATION

Regulations made under Section 16 (d) of the National Archives Law No. 48 of 1973 published in the Government Gazette of 15.12.1979 is amended as follows by the substitution of the following paragraph for paragraph 3 (C).

"(C) If any person wishes to inspect Public Archives accrued in terms of section 11 of the Law and referred to in paragraph 2 above during the period they remain closed, written approval for such inspection should be obtained from the Secretary to the President in case of records created by Commissions appointed either under the Commissions of Inquiry Act, or under special Presidential Commissions of luquiry Law No. 7 of 1978 and from the Secretary to the relevant Ministry in case of records created by Committees of Inquiry Appointed by Ministers under the Commissions of Inquiry Act".
